13 MS. NELSON: Ashley Nelson, address is 716 Greenway
14 Manor Drive, Apartment L, Florissant, Missouri 63031.

15 THE COURT: Okay. And you have your trustee -- the
16 trustee assigned to your case?

17 MS. BROWN: Yes, Your Honor. Tracy Brown.

18 THE COURT: All right. And do you want to tell me
19 what relief you're asking for today, and what happened to you?

20 MS. NELSON: I went through Critique Services and I
21 paid them 680 something dollars.

22 THE COURT: Do you have those receipts with you, by
23 chance?

24 MS. NELSON: I don't have them with me.

25 THE COURT: Okay. Can you --

1 MS. NELSON: I didn't know to bring anything; I'm
2 sorry.

3 THE COURT: Can you fax a copy or scan a copy and
4 send it to the trustee?

5 MS. BROWN: Yes, Your Honor, I requested that she
6 would send me copies of those. So she indicated that she can
7 do that.

8 THE COURT: Excellent.

9 MS. NELSON: I paid them in July, and they did not
10 start my case until November. I've called them numerous of
11 times. I left word numerous of times to go down to their
12 office to fill out the same paperwork over and over again. And
13 I still have not had my official court date. I think I saw the
14 attorney like three -- two months after I paid them.

15 THE COURT: Do you know who -- what that attorney's
16 name was?

17 MS. NELSON: It was Dean.

18 THE COURT: Dean Meriwether?

19 MS. NELSON: Yes.

20 THE COURT: We do not see him present today, okay.

21 MS. BROWN: And, Your Honor, I'd like to just
22 interrupt for just a second.

23 THE COURT: Sure.

24 MS. BROWN: We did have the 341 meeting, but it was
25 only after multiple settings that she agreed to go forward by

1 herself without representation.

2 THE COURT: Right, because Critique failed to furnish
3 you any representation.

4 MS. NELSON: Yes.

5 THE COURT: And no lawyer ever entered their
6 appearance. That's what the record shows.

7 MS. NELSON: Yes.

8 THE COURT: Correct?

9 MS. NELSON: That's correct.

10 THE COURT: Okay. So I was kind of moving that
11 along.

12 (Laughter)

13 THE COURT: And so did you pay them in cash?

14 MS. NELSON: I did.

15 THE COURT: Okay. And they just gave you a receipt?

16 MS. NELSON: They just gave me a receipt.

17 THE COURT: And then they never had --

18 MS. NELSON: No follow-up or anything. I --

19 THE COURT: Do you remember who you paid the cash to?

20 MS. NELSON: I can describe her, but I don't remember
21 her name. I know I did speak with Renee, she's like one of the
22 managers of Critique Services.

23 THE COURT: That's Renee Mayweather.

24 MS. NELSON: And I also spoke with -- they call her
25 Bae (phonetic).

1 THE COURT: Bae, yeah.

2 MS. NELSON: I spoke with her several times also.

3 THE COURT: And what did they --

4 MS. NELSON: They just gave me the runaround. That
5 someone will call, that I need to come back down and sign
6 another paper, or they were trying to contact me, but they was
7 calling the wrong number. And -- I mean they just gave me so
8 many different excuses.

9 THE COURT: So all you got was a bunch of excuses?

10 MS. NELSON: Yes.

11 THE COURT: No attorney showed up.

12 MS. NELSON: No.

13 THE COURT: They told you when you hired them that
14 you were going to have an attorney represent you, is that
15 correct?

16 MS. NELSON: Yes, that's correct.

17 THE COURT: And all you really dealt with -- well,
18 you did say you met with Mr. Meriwether.

19 MS. NELSON: I did finally meet with him, but even
20 then, I had to -- like there was no follow-up after that. I
21 had to keep calling them to see what was the next step, or when
22 was my court date. I didn't get my official bankruptcy number
23 -- case number until October.

24 MS. BROWN: Correction, Your Honor, that would be
25 November 23rd --

1 MS. NELSON: Yeah, November.

2 MS. BROWN: -- 2015.

3 THE COURT: November 23rd. And how many times did
4 you get continued? Or maybe the trustee knows.

5 MS. BROWN: It was originally set in December, it was
6 continued to January, and then it was continued again to
7 February 12th, and the case was heard on February the 12th.

8 THE COURT: And then you filed a request of me today
9 to --

10 MS. NELSON: Yes.

11 THE COURT: -- refund the Critique legal fees,
12 correct? So they did pay your filing fee.

13 MS. NELSON: Yes.

14 THE COURT: Okay. And that's part of that 600 and so
15 dollars. So -- do you remember how much you paid for the
16 attorney's fees?

17 MS. NELSON: I do not.

18 THE COURT: Okay. What was the total amount you paid
19 them?

20 MS. NELSON: \$684.

21 THE COURT: Eighty-four, okay, I've heard that number
22 before. All right. 684, you paid 335 for your filing fee in
23 this case.

24 MS. NELSON: Yes.

25 THE COURT: I think that's right. All right. So my

1 math tells me they charged you 349 in attorney's fees.

2 MS. NELSON: That's correct.

3 THE COURT: Did they try to charge you anything else?

4 MS. NELSON: No.

5 THE COURT: Okay. All right. Well, anything further
6 the trustee wants to say?

7 MS. BROWN: No, Your Honor.

8 THE COURT: Well, in this case, you'll -- since they
9 abandoned you, failed to represent you when they were required
10 to, and generally messed --

11 MS. NELSON: Wasted my time.

12 THE COURT: -- everything up, they will be required
13 to -- Critique and Dean Meriwether will be required to refund
14 \$349.

15 MS. NELSON: Okay.

16 THE COURT: And we'll enter a judgment in your favor
17 for that amount.

18 MS. NELSON: Okay.

19 THE COURT: Okay? Thank you for appearing.

20 MS. NELSON: Thank you so much.

21 THE COURT: Now you can go back to work.

22 MS. NELSON: Okay.

23 COURTROOM DEPUTY: Judge, the next person is Annette
24 Jones.

25 THE COURT: Hi. State your full name for the record,

1 and where you live.

2 MS. JONES: Annette Latosca Jones. I live at 3717
3 Louisiana Avenue, St. Louis, Missouri 63118.

4 THE COURT: And you also have a bankruptcy before
5 Tracy Brown, the trustee.

6 MS. BROWN: Yes, Your Honor. Tracy Brown appearing,
7 as well.

8 THE COURT: Oh, and let Mr. Clear swear you in.

9 COURTROOM DEPUTY: Please raise your right hand.

10 ANNETTE LATOSCA JONES, DEBTOR, SWORN

11 THE COURT: Oh, and -- and -- I got ahead of myself.
12 Did we want to have her come up and be sworn in? I'm sorry.

13 Ms. Nelson, I'm calling your case again. Please
14 raise your right hand.

15 ASHLEY MARIE NELSON, DEBTOR, SWORN

16 THE COURT: In the matter of Ashley Marie Nelson, 15-
17 48794. We've heard your testimony. Would it change any now
18 that you are under oath? Or would you give the exact identical
19 testimony?

20 MS. NELSON: I would give the exact identical
21 testimony.

22 THE COURT: Thank you very much.

23 MS. NELSON: You're welcome.

24 THE COURT: You can go back to work.

25 MS. NELSON: Thank you.

1 THE COURT: Now, Ms. Jones, you're under oath. And
2 the first thing I -- does the trustee want to make a statement,
3 or does --

4 MS. BROWN: Well, Your Honor, in this case, it was
5 also filed in November. It was -- her setting was in December.
6 That was continued to January.

7 After that, it was continued to February the 12th,
8 and that was the day that the case was heard.

9 I did question the debtor about whether or not she
10 had a copy of her bankruptcy schedules. And she indicated that
11 she had not been provided a copy of her schedules. So that was
12 one of the issues that I had, that she re -- she said she
13 reviewed them in the office, but she was never given a copy to
14 keep.

15 THE COURT: And so you were the only one in
16 possession of those schedules at this -- at this point in time,
17 is that correct?

18 MS. BROWN: That is correct, Your Honor.

19 THE COURT: And I take it her attorney was Dean
20 Meriwether?

21 MS. BROWN: That is correct, Your Honor.

22 THE COURT: All right. And -- Ms. Jones, how'd you
23 pay them?

24 MS. JONES: Cash.

25 THE COURT: And when did you pay them?

1 MS. JONES: August. I don't remember the exact date,
2 but it was in August.

3 THE COURT: How much did you pay them?

4 MS. JONES: I think it was \$684, or something like
5 that.

6 THE COURT: Just like the other lady, \$684, \$335 as
7 the filing fee, and \$349 for filing the bankruptcy --

8 MS. JONES: Correct.

9 THE COURT: -- is that correct? Okay. So obviously
10 you're 335 did make it to the Court --

11 MS. JONES: Um-hum, right.

12 THE COURT: -- because you got your filing fee paid.

13 MS. JONES: Um-hum.

14 THE COURT: And --

15 MS. JONES: Yes.

16 THE COURT: The yes and no works much better on --
17 the nodding of the head doesn't go too -- we don't pick that up
18 on the microphone.

19 But more importantly, what -- how many times did you
20 meet with Mr. Meriwether?

21 MS. JONES: Actually, I don't think it was Meriwether
22 that I met with at first. I think it was someone that got
23 their license suspended or something that I met with at first.
24 And that's how I continued to go with Meriwether.

25 THE COURT: Was -- was he somebody in his fifty --

1 late fifties?

2 MS. JONES: Um-hum. Oh, yes.

3 THE COURT: Can you describe him a little bit on the
4 record?

5 MS. JONES: Caucasian, older guy. Tall.

6 THE COURT: Mr. Dellamano.

7 MS. JONES: Yeah, I think that's his name.

8 THE COURT: Does that refresh your recollection?

9 MS. JONES: Yes.

10 THE COURT: Okay. Robert Dellamano. All right.
11 Then -- you had one conversation with him?

12 MS. JONES: Yup. I had one conversation with him, it
13 was very short. No more than five minutes.

14 THE COURT: Okay. And in regards to going to the
15 office, how many times did you have to go there?

16 MS. JONES: At least seven. After --

17 THE COURT: Seven times?

18 MS. JONES: Seven times after numerous calls to the
19 office. No one returning my call. The reception will tell me
20 that she'll have someone call me back; they never will call. I
21 was just concerned about when was my course going to be -- when
22 was I going to receive my case number.

23 THE COURT: All right. In regards to the people at
24 the office, did you have conversations with anyone named Renee?

25 MS. JONES: Yes, I had a conversation with Renee. I

1 also had a conversation with Bae. I had a conversation with
2 the receptions, I'm not for sure her name. They all gave me
3 the same answers: It was going to be filed. It was some issues
4 with them filing numerous cases, and mine just got lost. They
5 told me my case got lost, so that's why it didn't get filed.
6 And I paid them in August, and they say, "Oh, I'm sorry, you
7 know, it got lost, so we'll file it." Kept going back, and
8 they just kept giving me the runaround.

9 THE COURT: Are you asking me to refund \$349?

10 MS. JONES: Yes, I am.

11 THE COURT: Okay. Does the trustee have anything
12 further to add?

13 MS. BROWN: Well, Your Honor, I'm not sure how this
14 would be possible, but if there were some way that she could
15 get a copy of her case. I don't know if the Court could
16 provide her a copy, or how that would work.

17 THE COURT: We'll get that done.

18 MS. BROWN: Okay; thank you.

19 THE COURT: And we'll see if we can do that -- do we
20 want to do that now? Okay. Yeah, you can do it. I think
21 we're going to get that for you.

22 MS. JONES: Thank you.

23 THE COURT: Just stick around for a second.

24 MS. JONES: Okay.

25 THE COURT: All right. The Court will find that you

1 were abandoned, neglected, given the runaround, wide variety of
2 issues that would require Critique Services and/or -- however
3 they do business since they're in the phone book a couple
4 different ways -- and Dean Meriwether be jointly and severally
5 liable to you in the sum of \$349.

6 MS. JONES: Thank you.

7 THE COURT: Thank you. And we'll be ready for the
8 next one.

9 COURTROOM DEPUTY: Kevin Matthis.

10 THE COURT: Hi, Mr. Matthis.

11 MR. MATTHIS: Your Honor, how you doing?

12 THE COURT: State your name and address.

13 MR. MATTHIS: Kevin Shaunte Matthis, 12348 Shoreridge
14 Court.

15 THE COURT: Please raise your right hand, and be put
16 under oath.

17 KEVIN MATTHIS, DEBTOR, SWORN

18 THE COURT: All right. Mr. Matthis -- and Tracy
19 Brown's here again.

20 MS. BROWN: Yes, Your Honor. Tracy Brown, the
21 trustee on the case.

22 THE COURT: All right. Tell us a little bit about
23 your story. How much did you -- how much and when did you pay
24 Critique?

25 MR. MATTHIS: \$684.

1 THE COURT: Also.

2 MR. MATTHIS: In August.

3 THE COURT: Okay. And when did you pay that?

4 MR. MATTHIS: August.

5 THE COURT: Do you have that receipt?

6 MR. MATTHIS: No, I don't.

7 THE COURT: Do you have it -- could you provide it to
8 the trustee?

9 MR. MATTHIS: Uh, no, I don't have any receipts.

10 THE COURT: No receipts, okay. Did you pay them in
11 cash?

12 MR. MATTHIS: Yes.

13 THE COURT: And who did you pay, do you remember?

14 MR. MATTHIS: Renee, Bae --

15 THE COURT: Oh, you -- you paid Renee Mayweather
16 directly?

17 MR. MATTHIS: Yeah. Yeah.

18 THE COURT: And she gave you the receipt?

19 MR. MATTHIS: Yes. The receptionist, I don't know
20 which -- I'm not sure which one it was. Most of the time it
21 was -- it was a different one every time I came there, so --

22 THE COURT: A different person doing the reception?

23 MR. MATTHIS: Yes.

24 THE COURT: Okay.

25 (Ms. Brown and Mr. Matthis engaged in off-the-record colloquy)

1 MS. BROWN: I'd like to get on the record that he
2 made multiple payments, Your Honor.

3 THE COURT: Oh, he made multiple payments, okay. So
4 you made like five payments --

5 MR. MATTHIS: Yes.

6 THE COURT: -- over a period of time? Okay.

7 In regards to your bankruptcy, how -- how did they
8 treat you when you went in there?

9 MR. MATTHIS: They was nice, but they told me it
10 shouldn't take no more than 60 days. I started -- I first went
11 there July 7th, and I didn't get my case filed til November --
12 I'm not sure of the date.

13 MS. BROWN: I think it was November the --

14 THE COURT: Did you ever meet with an attorney?

15 MR. MATTHIS: No, I never met the attorney.

16 THE COURT: You never met an attorney?

17 MR. MATTHIS: No.

18 THE COURT: Who -- who went over your bankruptcy
19 schedules with you?

20 MR. MATTHIS: His -- the -- Renee, the Bae lady, and
21 there was another lady. I think her name was Tracy.

22 THE COURT: Tracy.

23 MS. BROWN: I have heard that before, Your Honor.

24 And I've been unable to confirm whether or not there is
25 actually a Tracy that works at the office, or whether or not

1 that's a name that's being used. It -- it was information that
2 was provided to me by someone who recognized Beverly Diltz,
3 indicated that she said she was Tracy. But because the person
4 recognized her, he basically responded and said you're not
5 Tracy, you're Beverly. So I'm still unclear whether or not
6 they have a Tracy there, or if they're saying that they're
7 Tracy.

8 THE COURT: They're -- that may be further evidence
9 to be developed. But the person using the name Tracy may very
10 well be Beverly Holmes-Diltz, is that what seems to be the
11 case? I've heard this information before.

12 MS. BROWN: Yes, Your Honor. I wish that I knew, but
13 I do not. I've been unable to get further -- clarification.

14 THE COURT: So you never met with a lawyer.

15 MR. MATTHIS: No.

16 THE COURT: Dean Meriwether signed your documents, is
17 that correct?

18 MR. MATTHIS: Yes. Every time I went to see the
19 attorney, they would say he wasn't there. And that's when I
20 ended up talking to one of the ladies.

21 THE COURT: Who are not licensed lawyers. Did they
22 say they were not licensed lawyers? Or did they just --

23 MR. MATTHIS: No, they didn't -- they didn't say they
24 were not lawyers. They just was the sultans of him. And they
25 had my case. Sent me back and forth to my job to get check

1 stubs for at least four months -- four to five months for the
2 same dates. And I did it like --

3 THE COURT: They kept losing the information.

4 MR. MATTHIS: Right. I did it about seven times.

5 THE COURT: Well, here's the thing, you hired this
6 outfit to provide you with a lawyer, albeit we've found in
7 other court proceedings it appears to be a rubber stamp. In
8 this case, it's beyond rubber stamp, you never saw a lawyer.

9 MR. MATTHIS: Right.

10 THE COURT: Are you asking me to refund \$349 that you
11 paid them because they abandoned you, never allowed you to have
12 legal representation, and never showed up in court?

13 MR. MATTHIS: Yes.

14 MS. BROWN: And, Your Honor --

15 THE COURT: Anything else, Trustee?

16 MS. BROWN: Yes, Your Honor; two additional things.
17 At the time he appeared at the 341 meeting, he actually came in
18 January and wasn't comfortable proceeding at that point on his
19 own. So we continued it again.

20 He came back in February, I did hear the case in
21 February. At that time, he indicated that he had a different
22 address that -- than what was on the pleading. So he filed his
23 own notice of change of address, and he also indicated that he
24 did not have a copy of his case, as well. So that would be an
25 additional request.

1 COURTROOM DEPUTY: I'm sorry. The folks on the
2 phone, can you please mute your phones? We have court going on
3 right now. Thank you.

4 MS. BROWN: That would be an additional request, Your
5 Honor, that he be provided with a copy of his case. He's
6 already filed his own change of address.

7 THE COURT: He doesn't have a copy either. Again,
8 he's totally abandoned. Never had an attorney, but he talked
9 to both Renee and, quote, "Tracy." The mysterious Tracy.

10 MR. MATTHIS: Yes.

11 THE COURT: All right. Thank you very much, Mr.
12 Matthis. We'll get a judgment sent to you in the mail. If you
13 stick around, we'll run you a copy of your pleadings --

14 MR. MATTHIS: Okay.

15 THE COURT: -- that you filed. That were filed on
16 your behalf by non-attorneys.

17 MR. MATTHIS: Yes.

18 THE COURT: So you really are representing yourself.

19 MR. MATTHIS: Yes.

20 THE COURT: All right. Thank you for appearing.

21 COURTROOM DEPUTY: Judge, our next case is Kimberly
22 Black, 15-48398.

23 Ms. Black, please raise your right hand.

24 KIMBERLY BLACK, DEBTOR, SWORN

25 THE COURT: All right. State your address.

1 MS. BLACK: 4938 Margaretta Avenue, St. Louis,
2 Missouri 63115.

3 THE COURT: All right. And you also had a bankruptcy
4 filed, and Ms. Brown was your trustee --

5 MS. BLACK: Yes.

6 THE COURT: -- is that correct?

7 MS. BLACK: Yes.

8 MS. BROWN: And I'm present, Your Honor, this
9 morning. Tracy Brown, the trustee on the case.

10 THE COURT: All right. How much did you pay these
11 people?

12 MS. BLACK: \$684.

13 THE COURT: All right. And tell me about what
14 happened to you.

15 MS. BLACK: I made two payments. I broken it in
16 half. My filing fee in July, and I paid my attorney fee in
17 August, and my case wasn't filed until November after several
18 calls to them. Because they told me that my case would be
19 filed ten days after I pay them the attorney fee. My case
20 wasn't filed until November.

21 THE COURT: Do you remember who you paid?

22 MS. BLACK: I paid Bae.

23 THE COURT: You paid Bae?

24 MS. BLACK: Um-hum.

25 THE COURT: Okay. And --

1 MS. BLACK: Yes, I'm sorry.

2 THE COURT: What's that?

3 MS. BLACK: Yes, I paid Bae.

4 THE COURT: All right. And did you ever meet with an
5 attorney?

6 MS. BLACK: Yes, I met with Dean Meriwether once.

7 THE COURT: Okay. And did he ever show up in court
8 for you, or come to any of your 341 meetings?

9 MS. BLACK: No. And I will call every -- on my way
10 to court, I would always call them to see if somebody would be
11 there to represent me. Just this February 12th when I called -
12 - actually I called them Monday, the 8th, and asked them would
13 I have representation. And they told me, "Yeah, you'll be
14 okay," that's what the -- they -- their words were. And when I
15 got --

16 THE COURT: That's what they told you?

17 MS. BLACK: Yes. When I got here that Friday, and
18 realized that I had to represent myself, but they never
19 answered calls. They never were straightforward with you to
20 tell you exactly what's going on. Actually when Ms. Tracy
21 suggested that I get a refund, I called them -- and this was
22 before my February 12th date. And I said that if I'm gonna --
23 she like, "Do you want a refund?" I'm like, "Well, if you
24 gonna represent me, no. But if you're not gonna represent me,
25 yes." "Oh, no, we'll be there. You'll be okay."

1 THE COURT: And they never showed up.

2 MS. BLACK: No.

3 THE COURT: They promised you --

4 MS. BLACK: And they didn't --

5 THE COURT: -- they'd be there, and didn't show up.

6 MS. BLACK: The Monday before my court date, and they
7 still didn't show up. And even I called them all that day
8 before court and after, and nobody ever answered the phone.

9 THE COURT: All right. And you would like \$349
10 refunded?

11 MS. BLACK: Yes.

12 THE COURT: Anything else to put on the record on
13 this case?

14 MS. BROWN: The only thing, Your Honor, I'd just like
15 to state that the case was filed in November, November 5th.
16 The first 341 setting was in December. We did not have all of
17 the documents, so we weren't able to hear it in December
18 anyway.

19 Ms. Black did appear in January, and we gave her
20 another continuance. And then in February when she came back,
21 she did decide to go ahead and have her case heard pro se, by
22 herself.

23 THE COURT: All right. Well, based on the complete
24 abandonment, dishonesty, failure to appear, we will refund your
25 alleged attorney's fees in \$349, and find against Critique

1 Services, LLC and Dean Meriwether individually.

2 MS. BLACK: Okay.

3 THE COURT: Thank you for appearing.

4 MS. BLACK: Thank you.

5 COURTROOM DEPUTY: The next case, Judge, is Jessica
6 White. This is an order to show cause.

7 THE COURT: Yeah, this order -- we've actually heard
8 from Ms. White before. And you want your attorney's fees
9 returned.

10 State your full name for the record.

11 MS. WHITE: Jessica White.

12 THE COURT: Well, go ahead and swear her in.

13 COURTROOM DEPUTY: Please raise your right hand,
14 ma'am.

15 JESSICA WHITE, DEBTOR, SWORN

16 THE COURT: All right. And, Ms. White, tell us what
17 happened to you. Oh, and Ms. Case is here, your trustee. I'm
18 sorry, get the appearances.

19 MS. WHITE: I actually started with them in August.
20 They kept telling me to come back. So when I finally came back
21 -- like I found my receipts and the dates. When I finally came
22 back in September, they took my attorney fees. Then they told
23 me to come back another month, which I did, which was on the
24 12th and I -- October the 12th.

25 THE COURT: 12th of which month?

1 MS. WHITE: October the 12th, I'm sorry.

2 THE COURT: Okay.

3 MS. WHITE: And I paid \$335. The first time, I paid
4 349. Then I came back on October the 12th and paid 335. And
5 at that time, they gave me a date, which I have another paper
6 to show my postpone for conference, which was October the 15th,
7 2015 at 5 p.m. When I got there, they said the systems were
8 down.

9 So then they kept giving me the runaround. Before --
10 actually before October, I think I came about two or three
11 times trying to get -- to pay my filing fee. They kept saying,
12 oh, we thought you was gonna to something else. I said, no.

13 So after I did my own research, and talked to Tracy,
14 I did talk to Renee, and someone else. I gave them actually --
15 I consulted with a lawyer through Washington University who
16 told me what I needed to do. So when I e-mailed them -- I have
17 the text to prove that I text Tracy information I found, and
18 that's when they finally filed my case in November.

19 THE COURT: And Tracy, can you --

20 MS. WHITE: Um-hum. I have her cell phone number,
21 and a proof I sent her a text, and she replied back to me.

22 THE COURT: Oh, well, let's put that cell phone
23 number on the record, and you -- if you could share that with
24 the trustee --

25 MS. WHITE: Um-hum.

1 THE COURT: -- this may be helpful in clearing up the
2 mystery of the magical Tracy.

3 MS. WHITE: I'm sorry, not Tracy. This is Ms. Renee.

4 THE COURT: Oh.

5 MS. WHITE: This is Renee.

6 THE COURT: Oh, this is Renee.

7 MS. WHITE: This is Renee, I'm sorry. Tracy's the
8 one I talked to and said she's gonna get back with me, but she
9 didn't. So then I talked to Renee -- this is Renee, I'm sorry.
10 She gave me her cell phone number, and text this information I
11 found according to Supreme Courts, what you're supposed to do
12 during bankruptcy when your system is down. And that's when
13 they finally filed my case.

14 I did my own research and got everything done. I
15 guess I put a fire under them, and they finally filed my case.

16 THE COURT: I see.

17 MS. WHITE: But I do have Renee number, and I have
18 the proof of texting, and she replied back to me.

19 THE COURT: Well, do we want to put that on the
20 record? We might as well. Let's have her --

21 MS. CASE: Go ahead and get the telephone number.

22 MS. WHITE: Her number is 618 area code, 580-6801.

23 THE COURT: All right.

24 MS. WHITE: And I also have proof when I went to
25 court, they suppose to give me a refund back.

1 THE COURT: Right.

2 MS. WHITE: And the letter I -- which was my fault, I
3 did sign the paper saying I will accept a refund, but I never
4 got it. So when I did do the refund, they --

5 THE COURT: Oh, is that paper you're referring to an
6 exhibit that's been filed --

7 MS. WHITE: Yeah.

8 THE COURT: -- in a number of cases saying that you
9 were given a refund, and then you were hiring Robert Dellamano
10 from --

11 MS. WHITE: Right, which is \$100 receipt that I
12 showed --

13 THE COURT: Once Mr. Meriwether was suspended, is
14 that correct?

15 MS. WHITE: Correct.

16 MS. CASE: To clarify, Your Honor. The debtor's
17 meeting of creditors was scheduled for December the 18th. That
18 day when I entered the courthouse, Mr. Dellamano was standing
19 in the rotunda area basically waving his clients off.

20 He came into the meeting of creditors' room and
21 basically told me that none of the debtors would be appearing.

22 At that point, Ms. White spoke up and said, no, that
23 she was there, and she wanted her case heard. I asked the two
24 of them to please step outside and let me know what was going
25 to occur.

1 Mr. Dellamano indicated he needed to go upstairs and
2 file some documents. He went upstairs and filed, I believe, an
3 entry of appearance and the disclosure of his compensation.

4 And I conducted the debtor's meeting. The problem
5 with the meeting was prior to the meeting, the trustee is
6 supposed to have received a 2014 income tax return, the
7 debtor's pay stubs, and the debtor's bank statement.

8 Not only did the -- I did not have any of those
9 things, the debtor indicated she had given them to Critique.
10 Mr. Dellamano indicated on the record he didn't have them.

11 The debtor was able to come up with some pay stubs
12 and her 2014 tax return, and we were able to conduct her
13 meeting.

14 At the end of the meeting when I looked at the entry
15 of appearance and the disclosure of compensation, it indicated
16 that the debtor had paid \$100 to Mr. Dellamano. And the debtor
17 said I haven't received a refund, and I haven't paid Mr.
18 Dellamano any money.

19 Mr. Dellamano assured the debtor she wouldn't have to
20 pay him any money.

21 After the meeting of creditors, the debtor contacted
22 me, she went to Critique. And when she was at Critique, she
23 asked for her full refund.

24 What they did instead was they gave the debtor a
25 cashier's check, not a check drawn on any attorney's trust

1 account, but a cashier's check, and the person who gave it to
2 her was Renee. And Renee instructed the debtor to endorse the
3 check, and the check was then -- was going to be given to Mr.
4 Dellamano.

5 We have a copy of that check, we have a copy -- and
6 now a second disclosure and retainer agreement for legal
7 representation, this one dated December the 18th, attempting to
8 modify the one that previously was filed with the Court. I
9 guess it's kind of like robbing the bank. I've robbed the
10 bank, now I've changed my mind, I want to give the money back.

11 But basically this debtor -- the next thing she had
12 to do is -- they didn't list all of her creditors on December
13 the 28th. She had filed her amended Schedule E and F. So
14 she's basically -- allegedly had representation from Mr.
15 Meriwether and Mr. Dellamano, but she has not.

16 THE COURT: And they didn't sustain that. Did you
17 actually endorse the cashier's check back to them?

18 MS. WHITE: Yes, I have a receipt of \$100 showing I
19 gave it back to them.

20 THE COURT: Yeah, we need to make a copy of that.
21 And --

22 MS. WHITE: I have all three of my receipts of every
23 time I paid.

24 THE COURT: Okay. Well, then we --

25 MS. CASE: And, Your Honor, I can deliver the copies

1 of the documents that I've received.

2 THE COURT: And also I -- I'd say that exhibit that
3 the trustee has examined and will be accepted into evidence.
4 Thank you for taking care of that, and we'll get you that
5 information.

6 So you not only got the runaround and got represented
7 by all kinds of attorneys that never showed up --

8 MS. WHITE: Right.

9 THE COURT: -- you did all the work yourself. And,
10 therefore, are you asking me to refund the \$349?

11 MS. WHITE: Yes.

12 THE COURT: And in this case, I'm going to find that
13 Critique Services, LLC, Mr. Dean Meriwether and Mr. Robert
14 Dellamano shall jointly and severally be liable to you in the
15 sum of \$349.

16 MS. WHITE: Thank you.

17 THE COURT: Anything further?

18 MS. CASE: No, Your Honor; thank you.

19 THE COURT: Thank you for appearing.

20 MS. WHITE: Thank you.

21 COURTROOM DEPUTY: Then we have one more, Judge, Ms.
22 McCline-Carter. Please raise your right hand, ma'am.

23 JEANNETTA McCLINE-CARTER, DEBTOR, SWORN

24 THE COURT: State your full name.

25 MS. McCLINE-CARTER: My name is Jeannetta

1 McCline-Carter. My address is 11844 Beckett Fall Road,
2 Florissant, Missouri 63033.

3 THE COURT: And I understand that you've recently
4 dropped off some information to us, so this may be the first of
5 two proceedings regarding your situation. Do you understand
6 that?

7 MS. McCLINE-CARTER: Yes.

8 THE COURT: All right. Tell me what happened to you.

9 MS. McCLINE-CARTER: Well, I filed my bankruptcy with
10 Critique, and I went to court --

11 THE COURT: About when, do you remember?

12 MS. McCLINE-CARTER: Oh, I can give you an exact
13 date. 2/7/2014. And I paid him on that day, and 2/20 -- I
14 mean 1/27/14 vice versa.

15 THE COURT: Okay.

16 MS. McCLINE-CARTER: And I went and I took the
17 course, you know the course that we're supposed to take.

18 THE COURT: Financial, yeah --

19 MS. McCLINE-CARTER: Yes.

20 THE COURT: -- education.

21 MS. McCLINE-CARTER: And I went to, you know, have my
22 thing with the Court, and the lawyer showed up there. And
23 everything went well. And while I was there --

24 THE COURT: Do you remember which lawyer showed up?
25 Was it Mr. Robinson or Mr. Meriwether?

1 MS. McCLINE-CARTER: Mr. Robinson.

2 THE COURT: Okay.

3 MS. McCLINE-CARTER: And I -- well, before I went to
4 court -- let me back up. I received a sheet from the Court
5 that they did not have my course. So I called, you know, the -
6 - the lawyer's office. And I can't tell you if I talked to Ms.
7 White, Renee or Tracy, or Bev. But anyway, they said that they
8 had everything, I didn't have anything to worry about.

9 So later I got my sheet saying that I did not -- you
10 know, wasn't approved because they did not have the course.
11 So -- and I'm here because I feel like I should have --
12 everything should have went well because I took the course, did
13 everything I was supposed to do. But I ended up going back to
14 Critique, and they gave me -- a Dean Weatherby (sic) attorney
15 thing to sign --

16 THE COURT: Just a -- just a second. Hey, somebody's
17 driving us crazy in court. Please put your phone on mute. We
18 can't hear what this witness is saying, and you're holding up,
19 you know, tens of thousands of attorney's fees on their 10
20 o'clock matter. I've got to get this done before we get to
21 Arch. Please mute.

22 MS. McCLINE-CARTER: Okay. I went back to the office
23 several times, and finally they had me to file a Dean Weatherby
24 (sic), that was in 10 --

25 THE COURT: Dean Meriwether, you mean?

1 MS. McCLINE-CARTER: Yeah. -- 10/11/2014. And I
2 didn't hear anything, so I went back again. And I was told
3 that they couldn't use him. So then they ended up giving me
4 Deborah --

5 MS. CASE: Dedra Brock-Moore.

6 MS. McCLINE-CARTER: Yes. And ever since then, I've
7 been playing runaround games. And I don't --

8 THE COURT: Well, they gave you that name, but she
9 didn't enter her appearance, did she?

10 MS. McCLINE-CARTER: Nobody showed up. I haven't got
11 anywhere since I did that. I just been calling, and calling,
12 going down there, and giving them more, you know, copies of
13 paperwork and stuff. And I called and "somebody get you back,"
14 nothing ever happened.

15 MS. CASE: Your Honor, is the problem with this case
16 that the debtor's second course that the debtor took that the
17 certificate was not filed with the Clerk, and, therefore, the
18 case was closed --

19 THE COURT: Without discharge.

20 MS. CASE: Without discharge. Is that what the
21 problem is?

22 MS. McCLINE-CARTER: Yeah, they --

23 MS. CASE: And, therefore, you do not -- you did not
24 receive your discharge in bankruptcy because Critique Services
25 did not file the certificate, and still has not filed the

1 certificate.

2 MS. McCLINE-CARTER: Yeah. I even asked for extra
3 copies to be even sent to them and to me.

4 MS. CASE: They're dated March the 13th, Your Honor,
5 2014.

6 THE COURT: All right.

7 MS. McCLINE-CARTER: And here's -- here's all the
8 paperwork.

9 THE COURT: Yeah, I think we're going to issue an
10 order to show cause why Critique and Mr. Robinson should not be
11 -- refund the \$349 you paid as attorney's fees. Is that the
12 correct amount?

13 MS. McCLINE-CARTER: No --

14 THE COURT: Let me double-check.

15 MS. McCLINE-CARTER: I paid 300 and 305.

16 THE COURT: Oh, okay, the old attorney -- 305 is the
17 old filing fee.

18 MS. CASE: The old filing fee amount.

19 THE COURT: Yeah.

7 THE COURT: Two sixty. Okay, yeah. We're going to
8 go ahead and waive her fee to reopen.

9 MS. CASE: So she should take the certificate
10 upstairs and file this?

11 THE COURT: Down to the fourth floor.

12 MS. CASE: Yes, Your Honor.

13 THE COURT: Yes, you should. You should take it
14 down. We're also going to file an order to show cause for your
15 abandonment in the amount of \$300 for attorney's fees. We're
16 going to find Mr. Robinson and Critique Services jointly and
17 severally liable for this amount after we send out an order to
18 show cause and see if there is a response.

19 MS. McCLINE-CARTER: Okay. Thank you so much.

20 THE COURT: That's the form of the pleading that you
21 will see, okay?

22 MS. CASE: I'll inform Mr. Radloff, the debtor's
23 trustee. Thank you, Your Honor.

24 THE COURT: Thank you for appearing.

25 MS. McCLINE-CARTER: Thank you.

1 THE COURT: That now concludes our 9:30 docket.
2 Everybody wants a five-minute break so they can assemble for
3 Arch. Court will be in recess.

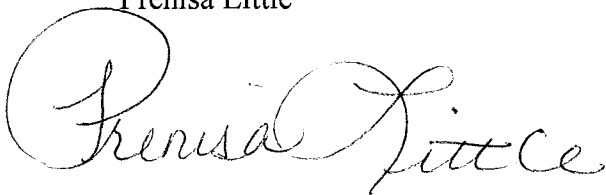

My name is Prenisa Little and I am writing this letter to inform the courts that the company Critique Services was supposed to be working on my behalf for a paid bankruptcy services for myself that I did not receive. Critique services did not do what they were supposed to do as far as reporting documentations to the courts, keeping me informed on my case information and also keeping an open line of communication with me. My case was filed on November 13, 2015 during that time I have had many issues with the company the first issue was that as explained to Renee (attorney secretary) and Tracy (customer service representative) that before filing that I had an open garnishment case, as well both of my utility company Ameren UE and Laclede gas was up for disconnection. Rebecca informed me that my new court date was January 15th 2016 and that all of the documentation that I gave to Critique Services has not been filed with the courts and that the information that was given to me for the additional creditors, garnishment information has not been submitted over. Once I went down to Critique Services and explained to them what was told to me they told me that the information was not submitted they explained because the attorney (dean Merriweather was removed from the case. I am asking the courts today to please allow me to enter the additional creditors that I have that I thought was submitted on my behalf by Critique Services to be entered into the system free of charge because those were services I paid for with an attorney. I am also asking the courts to grant me a refund of my attorney fees from the company because I had to represent myself in court on January 15, 2016 thank you for allowing me this opportunity and I hope to speak with someone soon.

ORDER

Attorney Dean D. Meriwether is an attorney affiliated with the “bankruptcy services” scam business known as “Critique Services” (the “Critique Services Business”). As has been established in numerous other cases before this Court, the Critique Services Business is rip-off operation that promises legal services that the business is deliberately designed to never provide. The “legal services” are provided by non-attorneys. That is, the business of the Critique Services Business is the unauthorized practice of law and the exploitation of debtors. The business currently is operated through Critique Services L.L.C., a company owned by convicted felon Beverly Holmes Diltz, who previously served time for fraud, and targets primarily the minority, working poor of the metropolitan St. Louis area. Diltz has been enjoined by federal court order from the unauthorized practice of law and from operating as a bankruptcy petition preparer. Every attorney, except one, who has ever been affiliated with the Critique Services Business has been sanctioned and suspended for his activities there, and two attorneys have been disbarred. Meriwether himself was suspended from the privilege of practicing before this Court on December 7, 2015, for (among many other things) client abandonment. And just this past week, Meriwether was suspended by the Missouri Supreme Court from practicing law in this state for one year. The Debtor in this Case had the great misfortune of becoming a client of Meriwether and the Critique Services Business.

On November 13, 2015 (before his suspensions), Meriwether filed the petition for the Debtor [Doc. No. 1], thereby commencing the above-referenced case. The § 341 meeting in this Case was set for December 18, 2015. However,

before the § 341 meeting was held, Meriwether was suspended from the privilege of practicing before this Court.

On March 3, 2016, the Debtor filed a letter motion (the “Motion to Disgorge”) [Doc. No. 17]. The Debtor seeks disgorgement of the attorney’s fees she paid at the Critique Services Business. In support of that request for relief, the Debtor alleges that:

- Meriwether and the Critique Services Business failed to provide all documentation required for the completion of her Case.
- Meriwether and the Critique Services Business failed to communicate with the Debtor regarding her Case.
- Meriwether and the Critique Services Business committed the unauthorized practice of law when a “customer service representative” named “Tracy” at the Critique Services Business office gave legal advice to the Debtor.
- ***The Debtor never spoke with Meriwether—despite the fact that he filed her Case for her*** and was her attorney of record.
- Robert J. Dellamano (“Bob”), another Critique Services attorney (who also has now been suspended by the Court) spoke with her—despite the fact that he was not her attorney—but he also provided her no legal services.
- On December 17, 2015, someone from the Critique Services Business telephoned the Debtor and lied to her, advising that her § 341 meeting of creditors scheduled for December 18, 2015 had been cancelled (This is not the first time the Court has heard this allegation regarding the Critique Services Business falsely advising its clients that the December 18, 2015 meeting of creditors had been cancelled.)
- The Debtor missed her § 341 meeting of creditors scheduled for December 18, 2015 because she had been falsely advised by the Critique Services Business that the meeting had been cancelled.
- When the Debtor began receiving documentation in the Case related to the fact that she had missed the § 341 meeting, she contacted the chapter 7 case trustee, Rebecca Case. Trustee Case advised the Debtor the

documentation required in her Case had not been filed and that the Debtor's new § 341 meeting date was January 15, 2016.

- The Debtor then went to the Critique Services Business office, and—only then, long after Meriwether's suspension—was finally told that her attorney had been suspended.

The allegations in the Motion to Disgorge are, sadly, nothing new. So many of these motions to disgorge attorney's fees have been filed with the Court since Meriwether's suspension that the Court has almost lost track of the total number. While the alleged facts are slightly different in each motion, they all reveal the same general story about Meriwether and the Critique Services Business: gross client abandonment and neglect; the unauthorized practice of law; and failure to render legal services.

The Court hereby directs that Meriwether and Critique Services L.L.C., the entity through which the Critique Services Business is operated, file any response that they may have to the Motion to Disgorge by Friday, March 11, 2016. In addition, the Court directs Trustee Case to make her best, good faith efforts to ascertain the surname of the "Tracy" individual who is alleged to work at the Critique Services Business. The Court has now heard reference to a "Tracy" in at least three different cases in connection with the rendering of services to a debtor. In this Case, it has been alleged that "Tracy" gave legal counsel. The Court directs Trustee Case to file a statement regarding her findings related to the surname of "Tracy" by Friday, March 11, 2016.

STATEMENT OF FINDINGS

Chapter 7 Trustee E. Rebecca Case files this Statement of Findings and in support thereof states the following:

1. The Court has jurisdiction in regard to this matter pursuant to 28 U.S.C. §§151, 157, and 1334, and Local Rule 81-9.01(B) of the United States District Court for the Eastern District of Missouri.

2. Debtor Prenisa Jenae Little (“Debtor Little”) filed her Chapter 7 Voluntary Petition for Relief on November 13, 2015.

3. E. Rebecca Case was appointed as the Chapter 7 Trustee (“Trustee Case”).

4. The Court’s Order, Docket Entry No. 18, was entered on March 4, 2016 and the Court directed Trustee Case:

... to make her best, good faith efforts to ascertain the surname of the “Tracy” individual who is alleged to work at the Critique Services Business. The Court has now heard reference to a “Tracy” in at least three different cases in connection with the rendering of services to a debtor. In this case, it has been alleged that “Tracy” gave legal counsel. The Court directs Trustee Case to file a

statement regarding her findings related to the surname of “Tracy” by Friday, March 11, 2016.”

5. On Friday, March 11, 2016 Trustee Case filed a Motion for Additional Time to Comply with Order, Docket Entry No. 18 and requested an extension of time until Thursday, March 17, 2016 to comply with the Court’s Order.

6. The Court granted Trustee Case an extension of time until Thursday, March 17, 2016 to comply with the Court’s Order.

DEBTORS

7. Debtor Little was contacted and Debtor Little agreed to execute the Affidavit which is attached hereto and incorporated herein as **Exhibit “1”**. When the Affidavit is reviewed, signed before a notary public and returned, it will be filed with the Clerk of the Court.

8. Attached to Debtor Little’s Affidavit as **Exhibit “1-A”** is Docket Entry No. 17, Debtor Little’s Motion to Amend, Motion to Waive Amendment Fee, Motion to Disgorge Attorneys Fees.

9. Attached to Debtor Little’s Affidavit as **Exhibit “1-B”** is a photograph provided by Debtor Little of “Tracy”.

10. Trustee Case was informed by Chapter 7 Trustees and has confirmed that the photograph of “Tracy”, **Exhibit “1-B”**, appears on the Better Business Bureau (“BBB”) website in an article dated August 5, 2015. The caption under the photograph states “Holmes”. The article states the following: *“BBB advises consumers to exercise caution when dealing with Critique Services...of 3919 Washington Blvd. The President and owner of the company is Beverly Holmes, who also uses the name Beverly Diltz and Beverly Holmes-Diltz. Renee Mayweather is manager.”* A copy of the BBB article containing the photograph is attached hereto and incorporated herein as **Exhibit “2”**.

11. The photograph of “Tracy” provided by Debtor Little was examined by Chapter 7 Trustees who identified the individual in the photograph as Beverly Holmes Diltz.

12. Trustee Case was provided with Debtor Chris Dandridge’s (“Debtor Dandridge”) email address by a Chapter 7 Trustee and informed that Debtor Dandridge was expecting to receive an email from Trustee Case in regard to the identity of “Tracy”.

13. Trustee Case sent an email to Debtor Dandridge’s attorney, Jennifer Alter, and his Chapter 7 Trustee with a copy to Debtor Dandridge, a copy of the email is attached hereto and incorporated herein as **Exhibit “3”**.

14. Debtor Dandridge called Trustee Case and left a message. Trustee Case returned Debtor Dandridge’s call and left a message.

15. Trustee Case sent Debtor Dandridge the email that is attached hereto and incorporated herein as **Exhibit “4”** and attached to it was **Exhibit “1-B”**.

16. Debtor Dandridge called Trustee Case and left the following message:

“Sorry for the phone tag. This is Chris Dandridge. The picture that you sent me that is Ms. Holmes a/k/a Tracy. She identified herself to me as Tracy. She never gave me her last name. She also signed on one of my receipts as Tracy. So that is the picture of Ms. Beverly Holmes who is also known as Tracy. If you need to call me, you can, my number is (redacted).”

Critique Services Has History of Bankruptcy Complaints, BBB Warns

St. Louis, Mo., Aug. 5, 2015 – A St. Louis business that offers discount bankruptcy services is the focus of new complaints from consumers who say they have been subjected to lengthy filing delays, mishandling of paperwork and poor customer service, Better Business Bureau (/stlouis/) (BBB) warns.

BBB advises consumers to exercise caution when dealing with Critique Services (http://www.bbb.org/stlouis/business-reviews/attorney-bankruptcy/critique-services-in-saint-louis-mo-110157169) of 3919 Washington Blvd. The president and owner of the company is Beverly Holmes, who also uses the name Beverly Diltz and Beverly Holmes-Diltz. Renee Mayweather is manager.



Critique Services has a 12-year history of problems with consumers, BBB, the Missouri attorney general's office and the U.S. bankruptcy court here.

Consumers have filed more than 130 complaints against the business since 2003, 20 of those in 2015.



"No one wants to help," said a Hazelwood man who paid \$630 in February for the company to file for bankruptcy on his behalf. He said more than a dozen visits to the company's office were "a waste of time" as he waited for his bankruptcy papers to be filed.

Several consumers said the delays have resulted in unexpected garnishments and continued calls from debt collectors.

"I felt like they just didn't care," said a consumer from Florissant.

Michelle Corey, BBB president and CEO, said it appears that many of Critique Services' problems could be fixed by improved communications. "Consumers should not have to call or visit a company repeatedly to get the answers to what seem like basic questions," she said. "No one appreciates being shuffled between people for weeks and months at a time."

BBB first issued a news alert on Critique Services in March 2003 when the business operated out of a suite in the 4100 block of Lindell Boulevard. At that time, complainants alleged they paid for services they never received, the company would not return their phone calls and the company would not pay requested refunds.

One year later, then Missouri attorney general Jay Nixon sued Critique, claiming its advertising was misleading and its services inadequate. Nixon said that Critique promised help to consumers in serious financial need but, once they were paid, the company was "very poor at delivering on even the most basic of services." That suit later was dismissed, but the reason for the dismissal is unclear.

In 2011, BBB notified Critique of a pattern of consumer complaints, again alleging service delays and difficulty contacting representatives of the firm.

In June 2014, U.S. Bankruptcy Judge Charles E. Rendlen III suspended then-Critique bankruptcy attorney James C. Robinson from practicing before the U.S. Bankruptcy Court in St. Louis. Court records show the suspension centered on Robinson's refusal to answer questions about his relationship with Critique. That suspension is being appealed.

BBB cited the company again for a pattern of complaints last month. BBB said the pattern involved the company's failure to perform contracted work, failure to issue refunds, failure to return phone calls and overall poor customer service.

Holmes blamed the company's recent problems on Robinson's issues with the bankruptcy court. She said the company had to hire other attorneys to handle customers' cases, resulting in filing delays.

"It threw everything into a tailspin," she said.

She also said she has hired additional staff and instituted a new telephone system to deal with breakdowns in communication between consumers and the company.

"I have worked seven days a week, 12 hours a day to make sure I get this under control," she said. She said this week that all complainants have either been assigned court dates or offered refunds.

The Florissant consumer said she first contacted Critique in January, paying the company \$600 in May for help in filing for bankruptcy. She said she finally got an August court date, but not before she was notified that a creditor had garnished her wages because of the delay. "It's extremely frustrating," she said.

A woman from Overland said Critique had filed bankruptcy papers on her behalf last year, but the case was dismissed because the company had not filed required paperwork. She said recently she has been unable to reach anyone at the office for more than a month.

A St. Louis woman said she made her final payment to Critique near the end of May and the company told her that her case would be filed in ten days. She, too, said she began receiving garnishment notices from creditors who are on her bankruptcy list, causing her to fall behind on rent and other expenses.

BBB offers the following tips when considering contracting for bankruptcy or other services:

- Research the business and owners carefully before signing a contract or paying any money. Check the company's BBB Business Review (/search/) at www.bbb.org/stlouis/ or by calling 314-645-3300. If a business refers you to an attorney, check that attorney with BBB and make sure he or she is licensed to practice law in your state.
- Ask for references and contact them.
- Before paying anything, make sure you have a signed contract outlining exactly what work is to be done, a timetable for completion and an explanation of what happens if either the business or consumer reneges on the agreement.
- Pay by credit card whenever possible in case you need to challenge the payment.
- Do not pay everything in advance. It is a good rule to pay as work is completed.

STATEMENT OF FINDINGS

Chapter 7 Trustee E. Rebecca Case files this Statement of Findings and in support thereof states the following:

1. The Court has jurisdiction in regard to this matter pursuant to 28 U.S.C. §§151, 157, and 1334, and Local Rule 81-9.01(B) of the United States District Court for the Eastern District of Missouri.

In this case, it has been alleged that “Tracy” gave legal counsel. The Court directs Trustee Case to file a

26. Attorney Laurence Mass responded by email on behalf of his clients, Beverly Holmes Diltz and Critique Services, LLC and stated the following:

"Rebecca

My clients do not know of a person named Tracey. There was no one that they know of who worked on the staff of any attorney with whom CS LLC had an agreement named Tracey. The only reference to Tracey that they know of was by

RESPONSE TO THE ORDER DATED MARCH 18, 2016 OF JUDGE RENDLEN

COME NOW Respondents Critique Services, LLC and Beverly Holmes-Diltz (“These Respondents”) and in response to this Court’s Order dated March 18, 2016 in the above captioned matter state as follows:

1. As with These Respondents’ Response to the Show Cause Order in Case No. 16-0402, These Respondents require a sufficient period of time to conduct full discovery to identify the person referenced as “Tracy” in the report of E. Rebecca Case, Chapter 7 Trustee for Prenisa Jenae Little in Case No. 15-48605-705, filed on March 17, 2016. Within the limited time provided by this Court to respond to its Order of March 18, 2016 These Respondents have been able to find some additional information as set forth below.

2. These Respondents also request an evidentiary hearing on all matters raised by the Court in its Order of March 18, 2016 so that they might properly cross-examine any persons who are claiming that a woman named “Tracy” provided services to them at the “offices of Critique Services, LLC.”

3. An Affidavit submitted by a person who claims that a woman named “Tracy”

served them, even when identifying a picture, without the opportunity to cross-examine such Affiant does not sufficiently accord due process as guaranteed by the United States Constitution.

4. These Respondents again raise the issue that in the matter of accusations concerning Critique Services, LLC that Judge Rendlen should recuse himself for the reasons set forth in its Motion for Recusal and also because he is acting as the prosecuting authority as well as the judge. The due process clause of the United States Constitution requires that the matter be heard by a different judge who is not involved in prosecuting the matter. Federal Statute, 28 U.S.C. §455 requires the same result.

5. In her statement marked as Exhibit 1-A attached to the Statement of Findings of E. Rebecca Case, Ms. Little states that she talked to a woman named “Tracy” who she said was a “customer service representative of Critique Services, LLC.”

6. As noted in Ms. Case’s findings, Critique Services, LLC stated to Ms. Case through counsel, that Critique Services, LLC had only one person conduct its business, its sole member, Beverly Holmes Diltz, and that the attorneys with whom Critique Services, LLC had a contract did not have an employee named “Tracy.”

7. Attached hereto as Exhibit A is a copy of a receipt issued to Ms. Little on November 4, 2015 showing receipt of \$684.00, the amount she paid for attorney’s fees (\$349) and filing fees (\$335) in order to begin her bankruptcy. It is signed by Nicky Lee, an African-American woman who worked in the offices of the attorney with whom Critique Services, LLC had an agreement in November 2014.

8. Ms. Lee, when working for that attorney, worked as the customer service representative in handling receipt of fees and questions from persons who sought the services of

the attorney. A copy of Nicky Lee's signature on another document is also attached hereto as Exhibit B.

9. Ms. Lee is an African-American of similar height to Ms. Diltz.

10. Ms. Little should be required to produce all documents she has from her contacts with Critique Services, LLC or any attorney with a contract with Critique Services, LLC.

11. With regard to Christopher L. Dandridge, Sr., that case, Cause No. 16-40644 is presided over by Judge Schermer, not Judge Rendlen. Should there be any impropriety, it is for Judge Schermer to determine as part of his administering that Debtor's bankruptcy.

12. The Affidavit of Mr. Dandridge is unsigned. The receipt supposedly signed by "Tracy" that he states he received from the staff of the attorney working under agreement with Critique Services, LLC was not attached as Exhibit 5-B to Ms. Case's Statement of Findings. That exhibit page is blank. Without that receipt, These Respondents cannot begin to test the validity of Mr. Dandridge's claim that he dealt with a woman named "Tracy" and that woman appeared to be Ms. Diltz.

13. These Respondents have attempted to find Mr. Dandridge's file among the records of the attorney with whom Critique Services, LLC had an agreement, but have not been able to locate it although their search continues. a copy of the receipt would most likely be in that file.

14. These Respondents request that this Court order Mr. Dandridge to produce all documents that he has with regard to any contact he had with Critique Services, LLC and/or any attorney with whom Critique Services, LLC had a contract so that These Respondents can test the validity of Mr. Dandridge's statements that are not supported by a signed Affidavit.

15. It is not clear from Ms. Case's Statement of Findings that Debtor Leander Young identified a woman named "Tracy" that supposedly provided services to him at Critique Services, LLC's office and the office of the attorney Dean Meriwether.

16. Although the Court's Order directed to These Respondents only requested a response to the findings of two Debtors with regard to the identity of "Tracy," the comments in the Statement of Findings with regard to Leander Young infer that he might have made a claim that a woman named "Tracy" serviced him and/or attended a hearing with him, but that after further investigation that person whom he thought was "Tracy" was actually attorney Ms. Brock-Moore.

17. If so, that would be evidence that "Tracy" did not work at the offices in which Critique Services, LLC is located and that Debtors, such as Mr. Young, were incorrect in making such allegations.

18. This Court should hold a hearing on any investigation into who "Tracy" might be, require any person alleging that a "Tracy" provided services to that person produce all documents that person has concerning any dealings that person had with Mr. Dean Meriwether, anyone on his staff, or anyone at the offices that are claimed to be the offices of Critique Services, LLC.

WHEREFORE, These Respondents pray that this Honorable Court require that Mr. Dandridge and Ms. Little produce all documents and writings they have concerning their relationship, if any, with Critique Services, LLC or Mr. Dean Meriwether or his staff; require Ms. Case to provide them with a legible copy of what she has stated was the receipt which she labeled as Exhibit 5-B, but which was blank when attached to her Statement of Findings; grant a period of no less than three months to conduct discovery; assign this matter for a hearing to another

Judge who is not acting as prosecutor in this matter; and grant such other and further relief as the Court deems just under the circumstances herein.

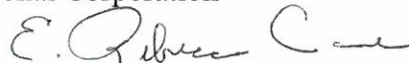
8. Trustee Case was appointed as the Chapter 7 Trustee.

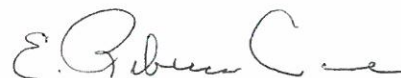

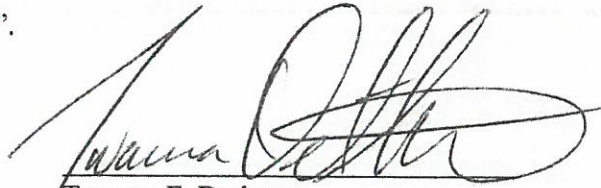

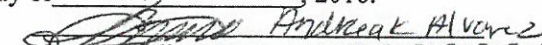
