Application To Pay Filing Fees in Installments

This procedure explains how to file an application to pay filing fees in installments using the electronic case filing system (CW/ECF).

Internet users will access CM/ECF through PACER and will use two different sets of logins and passwords; one for CM/ECF filing and the other for PACER access to queries and reports.

This module will assume that the internet user has accessed the court's web site with their court assigned CM/ECF login and password.

STEP 1 Click the <u>Bankruptcy</u> hyperlink on the CM/ECF Main Menu. (See Figure 1.)



STEP 2 The BANKRUPTCY EVENTS screen displays. (See Figure 2.)



• Click on the <u>Motions/Applications</u> hyperlink.

STEP 3 The CASE NUMBER screen displays. (See Figure 3.)

- If you have already accessed a case in this session, the number of the last case accessed will be displayed. Leave this number if it is the correct case for this application, or enter the correct case number (yy-nnnn), including the hyphen.
- Enter the correct case number and click [Continue]
- **NOTE:** If the system prompts that you have entered an invalid case number, click the browser **[Back]** button to try again.

The CASE INFORMATION screen displays. Click [Continue].

STEP 4 The APPLICATION FOR COMPENSATION screen appears. (See Figure 4.)

- The final installment must be paid within120 days on Chapter 7 cases.
- The remaining installment fee must be paid through the plan on all Chapter 13 cases.

- If the final docket text is incorrect:
 - Click the browser **[Back]** button to find the error(s) and proceed with the event.
 - To abort or restart the transaction, click the **Bankruptcy** hyperlink on the **Menu Bar**.
