**PUBLIC NOTICE**

**Notice of Increase in Chapter 13 Attorney Fees**

Please take notice the United States Bankruptcy Court for the Eastern District of Missouri has amended the **Chapter 13 Attorney Fee Guidelines** found at page 14 of the Court's Procedures Manual to authorize increased Chapter 13 attorney fees following the effective date of the Bankruptcy Abuse Prevention and Consumer Protection Act. The Court has also amended **Local Form 6, Chapter 13 Attorney Fee Election Form**.

For cases filed on and after October 17, 2005, the following fees are authorized.

1. **Flat Fee Option - Flat Fee.** Attorneys for Chapter 13 debtors who elect the Flat Fee Option may receive \$3,000 (or \$3,189 plus the filing fee, if the filing fee is advanced) without application to the Court.
2. **Fee Application Option - Initial Fee.** Attorneys for Chapter 13 debtors who elect the Fee Application Option may receive, without filing a fee application, an initial fee of \$2,300 (or \$2,489 plus the filing fee, if the filing fee is advanced).

Attorney Fee Election Form

If this Attorney Fee Election Form is not filed with a Chapter 13 petition, the Chapter 13 Trustee will object to the confirmation of the Chapter 13 plan, and counsel may not be eligible for the “Flat Fee Option.”
